# JOIN US AS AN ASSOCIATE SUPPORTER OF THE JUSTICE REINVESTMENT NETWORK AUSTRALIA

The Justice Reinvestment Network Australia (JRNA) is the community-controlled representative national body of communities working in justice reinvestment (JR). We support Aboriginal and Torres Strait Island communities at any stage of their justice reinvestment work through a strong and unified national body.

We welcome supporters of justice reinvestment to be a part of our network through Associate membership. Applications are open to those organisations and people who demonstrate a commitment to work in alignment with the objective of JRNA, offer skills or expertise to JRNA and have demonstrated understanding or connection to justice reinvestment.

## Eligibility

JRNA welcomes supporters of our communities and the JR movement to join as Associates of JRNA.

You are eligible to apply to become as Associate of JRNA if you have paid your application fee (currently \$10) and:

- Have demonstrated a commitment to work in alignment with the objectives of JRNA; and
- are either:
  - An Aboriginal and Torres Strait Islander organisation or group that does not qualify for membership, or
  - a non-Aboriginal and Torres Strait Islander organisation; and
- offer skills or expertise to JRNA and/or have a demonstrated understanding or connection to JR.

## How do you become an Associate?

Complete the Associate application form and pay any required application fee to the Company Secretary.

The JRNA Board will consider all applications and may ask for further information to support a decision.

## What role do Associates have?

As a supporter of JRNA, Associates:

- contribute to the work of JRNA,
- receive updates and invitations,
- receive notice of general meetings,
- attend and speak at general meetings (non-voting).

Annual subscription fees from Associates support the work of JRNA. The tiered annual subscription fee structure for Associates is currently:

- \$300 for Associates with an annual turnover of up to \$500,000;
- \$500 for Associates with an annual turnover of over \$500,000 up to \$1 million;
- \$700 for Associates with an annual turnover of over \$1 million up to \$3 million; or
- \$900 for Associates with an annual turnover of over \$3 million.

The Board has discretion in determining fees - please contact us if you would like to discuss the annual subscription fee prior to application.


