# JOIN US AS A MEMBER OF THE JUSTICE REINVESTMENT NETWORK AUSTRALIA

The Justice Reinvestment Network Australia (JRNA) is the community-controlled representative national body of communities working in justice reinvestment (JR). We welcome all communities at any stage of their justice reinvestment work to join us in creating a strong and unified national body.

Membership is open to Aboriginal and Torres Strait Islander organisations or groups who are engaged in grassroots, place-based justice reinvestment work and controlled and operated by a majority of Aboriginal and Torres Strait Islander people. Your organisation or group must have a governing body made up of a majority of Aboriginal and Torres Strait Islander people, be connected to the community or communities in which you operate and non-profit.

## **What role do members have?**

Members of JRNA have roles including voting rights to decide on important matters such as appointment and removal of directors, changes to the constitution, approval of financial statements and input into the future plans for JRNA.

Members from your State or Territory will together nominate and elect a Director from your jurisdiction to sit on the JRNA Board.

The liability of members on any winding up of the organisation is limited to the \$10 guarantee.

## **How do you become a member?**

The JRNA Board will consider all applications and may ask for further information to support a decision.

## **What are the benefits of membership?**

JRNA Members have access to independent, grassroots community justice reinvestment expertise, knowledge, resources and support through:

- National Justice Reinvestment Community Support Service, including 1:1 implementation support, guidance and advice according to your community's needs and ways of working
- Two-way learning opportunities through the Shared Learning Hub, with access to regular knowledge and skills workshops, professional development opportunities, governance support, quarterly network meetings and events bringing together all communities working in JR across the country
- Forums for joint advocacy and system reform initiatives, joining together the grassroots knowledge and experiences from all of our communities

You will also have access to Member-only resources, tools, templates and videos to support your work.
